- an indication of how you would go about seeking and representing the needs of the School's c400 postdocs, in liaison with the wider postdoc community

The Head of School will review all expressions of interest and will select a representative on the basis of the criteria outlined above.

## Council of the School of the Humanities and Social Sciences: Research Committee

### Terms of Reference

- (a) Consider strategic issues relating to research funding (grants, other sources and Research Assessment exercises) and themes and advise Council of the School accordingly;
- (b) Develop School-level policy relating to research funding, including identification of strategic research priorities;
- (c) Monitor research funding performance, develop forecasts for planning purposes and identify areas for growth;
- (d) Enable large interdisciplinary projects, whether internal to the School or involving external partners, where a School-level body can act to increase opportunities or capability;
- (e) Distribute research support funding allocated by Council of the School, including oversight of the Philomathia Research Programme;
- (f) Monitor and encourage the representation of the School and the University on the Boards of the major funding bodies, to inform research strategy and the development of policy;
- (g) Oversee the partnership between the School and the University Research Office (URO)
- (h) Oversee research facilitation, including the School-based Research Facilitators and the support provided by CRASSH
- (i) Oversee School-level activity and policy relating to postdoctoral researchers, including researcher development planning and Concordat

The Committee is chaired by the Head of the School. The members are appointed by the Head from time to time to normally serve a three-year term, to include:

- one representative from each institution with a seat on the Council of the School;
- the School's nomination to the University Research Policy Committee;
- the Director of CRASSH; and other members co-opted at the discretion of the Head.

The Assistant Director of the Research Office, School Finance Manager and the School Research Facilitators are invited to attend.

The work of the Committee will be supported by a cross-School forum for Research Grant Administrators in the arts, humanities and social sciences
